The George Hettrick Community Law Center in the Church Hill neighborhood of Richmond was established in 1990 as a Hunton Andrews Kurth satellite office to provide pro bono services to financially limited persons in the Richmond area. Chip Nunley serves as the managing partner of the office and Sandy Reynolds is the office's manager and administrator. Michaela Ross and other Richmond volunteers receive cases through Church Hill referrals and provide consults to low-income Virginia residents. Carolina Rivas, New York Pro Bono Fellow

Carolina assists low-income clients with immigration matters, dividing her time between clients at Kids in Need of Defense (KIND) and the Legal Aid Society in New York City. Carolina advises migrant youth, including unaccompanied children, on potential immigration relief applicable to their circumstances. In FY21, Carolina assisted 39 immigrant children or women with their immigration status, the majority being victims of abuse, neglect or abandonment. She also mentored and assisted 11 lawyers with immigration cases referred to the firm by organizations including Sanctuary For Families and the Southern Poverty Law Center.



Michaela Ross, Richmond Pro Bono Fellow

Michaela assists low-income clients with a variety of civil pro bono matters, dividing her time between clients at the firm's Church Hill pro bono office and the Central Virginia Legal Aid Society. Michaela concentrates on housing cases in Richmond, Henrico and Chesterfield General District Courts. She defends tenants from eviction, assists them in wrongful evictions and tenant's assertions of poor conditions, and also handles family law and guardianship matters. Michaela was admitted to the Virginia Bar in December of 2020 and has since represented more than thirty Church Hill and CVLAS clients with their civil legal aid needs.





Henry Sturm, Houston Pro Bono Fellow

As the firm's first pro bono fellow in Houston, Henry assists low-income clients on civil legal aid cases through Houston Volunteer Lawyers, the pro bono arm of the Houston Bar Association. He also assists the organization with its virtual clinics. His practice focuses exclusively on pro bono housing, family law, criminal record expungement and guardianship matters. He recently represented a mother of three to overturn the termination of her Section 8 housing assistance, allowing the family to remain in their home. Admitted to the Texas Bar in November 2020, Henry has dedicated more than 750 hours to low-income clients in need of civil legal services.



Geri Greenspan, Charlottesville Senior Pro Bono Fellow

Geri represents low-income clients as part of the firm's partnership with the University of Virginia School of Law and Legal Aid Justice Center (LAJC) in Charlottesville. Geri's practice focuses exclusively on pro bono matters, and concentrates on representing and advising domestic violence survivors seeking court protection for themselves and their children from an abusive partner. In FY21, Geri continued her service as a member of the Charlottesville Human Trafficking Task Force. She is a regular volunteer for LAJC's Medical / Legal Partnership with the UVA Hospital. On top of Geri's caseload of representing victims of domestic violence, she is currently seeking clemency for a prisoner, who suffers from a rare genetic disorder, to be transferred from a prison to a secure hospital, and assisting in another prisoner's rights case in Virginia.

Amnesty International Deadly Force and Police Accountability Report

Hunton Andrews Kurth partnered with Amnesty International USA (AIUSA) to provide thousands of hours of assistance to AIUSA's Deadly Force and Police Accountability Report. Lawyers Committee for Civil Rights Under Law UT Admissions Case

With the Lawyers Committee for Civil Rights Under Law, Hunton Andrews Kurth filed a motion to intervene on behalf of three organizations and eight students of color to defend the meaningful inclusion of race in UT Austin's admissions process in the case Students for Fair Admissions (SFFA) v. University of Texas at Austin (UT). A federal district court granted the group's motion to intervene as defendants in the challenge to UT Austin's race-conscious admissions policy, and the group has moved to dismiss SFFA's claims for lack of standing. - Carter Simpson, Ryan Phair, Dan Stefany and Paul Mayer (Washington, DC)

Removal of Richmond's Confederate Monuments

Hunton Andrews Kurth successfully represented the City of Richmond on a pro bono basis in several cases related to the City's removal of its Confederate monuments. Law Firm Antiracism Alliance

Representation of Former Congressional Candidate

Inner City Law Center Los Angeles Cities Trackers Project / Eviction Moratorium Research

Local governments across Los Angeles County passed tenant protections in response to the COVID-19 pandemic. The LA County Board of Supervisors issued an order that protects all tenants in unincorporated Los Angeles County, as well as tenants in incorporated cities within Los Angeles County, that have not yet passed eviction protections. Inner City Law Center, in collaboration with the Healthy LA Subcommittee on Tenant Protections, developed a tracker to keep tabs on which of 88 cities have passed eviction protections and whether a given city's protections are stronger or weaker than the County protections. Hunton Andrews Kurth lawyers updated the tracker on a weekly basis for a year by researching 15 cities, concluding their research in March 2021. - Jennifer MikoLevine and Ryan Evans (Los Angeles)

Richmond's Housing Crisis and Eviction Diversion Program

In response to Richmond's record of the second most evictions of any large city in the country, Richmond legal service providers and law firms developed the Eviction Diversion Program (EDP). EDP matches qualifying tenants with volunteers serving as third-party neutrals to negotiate payment plans that deploy grant funds to help pay overdue rent. Hunton Andrews Kurth lawyers Josh Hanbury, Brian Wright and Jendy Daglio have led the entire effort and trained numerous volunteers. Because of their efforts with EDP, hundreds of Richmond tenants have avoided eviction and had enduring stains on their record eliminated. A handful of Richmond lawyers have dedicated more than 1500 hours in FY21 to keeping families, who are facing eviction, in their apartments and secured thousands of dollars in damages for wrongfully withheld security deposits, unlawful evictions and landlords' failure to make necessary housing repairs. - Brian Wright, Josh Hanbury, Jendy Daglio, Chip Nunley, Nate Shepherd and Jon Caulder (Richmond)

Dallas Evictions 2020

Dallas Evictions was founded by an alliance of lawyers with the mission of helping tenants who may lose their homes as a result of the COVID-19 pandemic. The organization not only provides legal advice for families who do not qualify for traditional legal aid, but also provides financial assistance to help those in danger of losing their homes. Hunton Andrews Kurth lawyers in Dallas are active in the effort and have represented five tenants in their wrongful evictions. - John Gerhart, Charlie Truslow, Ted Huffman and Sam Johnson (Dallas)

HomeAgain's Acquisition for More Affordable Housing

Hunton Andrews Kurth represented HomeAgain, a non-profit organization with the mission to help those experiencing homelessness to secure and maintain affordable housing, in its venture to acquire a Richmond building that would add more affordable housing to Richmond.

Wrongful Eviction Case for Disabled Tenant in Miami

After a firm client, referred by Legal Services of Greater Miami, had a massive sewage back up that filled her entire apartment, she reported the unlawful unsanitary conditions to the City and the landlord was fined. The building management, however, refused to relocate her or pay her hotel expenses. Moreover, she was refused reentrance into the apartment even though she had a standing lease, essentially rendering her homeless. Hunton Andrews Kurth volunteers successfully defended the client against the illegal eviction. As a result, the lease was cancelled and the security deposit was transferred to a new lease for a different unit. Additionally, the landlord agreed to provide rent abatement for more than two months and issued a credit for one month's rent. - Juan Enjamio and Dan Butler (Miami)

Atlanta Volunteer Lawyers Foundation and Saturday Lawyers

During FY21, Atlanta lawyers assisted Atlanta Volunteers Lawyers Foundation (AVLF) in eight landlord/tenant cases and participated in the Housing Court Assistance Center program that provides real time help to unrepresented tenants in housing courts. Through the AVLF Saturday Lawyers Program, Mack Emerson and Andy Koelz represented a low-income client in a dispute with her former landlord. The client lived in an apartment complex where the air conditioning unit failed and her landlord refused to make repairs for several months. The team drafted a demand letter seeking compensation for the diminished value of the apartment and the excess utility costs associated with the portable air conditioning unit that the client was forced to rely upon. After receiving no response, the team filed suit and prepared for trial. A few days before the trial was scheduled, the team was able to secure an \$800 settlement for the client. - Mack Emerson, Andy Koelz, Larry Bracken and Shelly Anderson (Atlanta)

Richmond Pro Bono Fellow Housing Case

Richmond pro bono fellow Michaela Ross won a significant case in Richmond General District Court regarding wrongful eviction. Michaela represented a tenant in a boarding house who was wrongfully evicted and then denied the opportunity to recover his possessions before they were placed on the street. During cross-examination in the initial trial, the landlord attempted to evade the questions by repeatedly giving non-responsive answers, to which Michaela objected. The judge called a sidebar and told the landlord's counsel that in six years on the bench she had never held a witness in contempt for refusing to answer questions and that she was on the verge of doing so with the landlord. At the conclusion of the case, the judge awarded Michaela's client more than \$7,500 in damages and also awarded attorneys' fees of more than \$1,800. Immediately after court, the landlord wrote a check to Ross's client for the full amount of damages, and one to Hunton Andrews Kurth for attorney's fees. - Michaela Ross (Richmond)

City Bar Justice Center Homeowner's Stability Project

Hunton Andrews Kurth is representing a client through the New York City Bar Justice Center's Homeowner Stability Project which provides assistance to low and moderate income homeowners threatened with foreclosure or who were victims of predatory lending. The firm's client was selling his home when a title search discovered there were liens against his home. Harris County Mail-In Ballot Matter before the Supreme Court of Texas

Hunton Andrews Kurth represented Harris County, Texas before the Texas Supreme Court in responding to a petition for mandamus by the Texas Attorney General that sought to force local election officials to discourage mail-in voting during the global COVID-19 pandemic. HuntonAK lawyers argued that lack of immunity to Covid-19 was a qualifying "disability" under the Texas statute authorizing voters to cast mail-in ballots. The firm recently completed an asylum application for a young man who fled Turkey, having been persecuted for his religious and political beliefs. He and his family follow the teachings of the peaceful Gulen Movement, which the current Turkish government claims is a terrorist organization, while the United States disagrees. The client has been subject to arrest and physical abuse, and seen numerous family members imprisoned and indicted for so-called political crimes. Successful Outcome for a Survivor of Extreme Abuse

In the midst of the pandemic last summer, Hunton Andrews Kurth's client received an approval notice for a U visa permit and corresponding work permit as a survivor of domestic violence. Hunton Andrews Kurth attorneys filed her initial U visa application more than five years ago. After two years of coordinating fingerprinting and procuring court orders in the client's native country, Hunton Andrews Kurth also received preliminary approval for her children to join her in the United States. She is now able to work legally and continue to plan for her future here in the US, as she will be eligible for a green card in three years. - Jenna Goldman (New York)

MAIP Screening Committee and 20 Year Retrospective Review Project

In FY21, Hunton Andrews Kurth attorneys dedicated 950 hours to reading and screening files from prisoners who are seeing assistance from the Mid-Atlantic Innocence Project (MAIP). Volunteers also partnered with four corporate clients to review MAIP's exonerees in an effort to develop a basis for reform proposals to prevent/reduce wrongful convictions.

Clemency Relief in Five Year Matter

Kenyon Gadsden was serving a life sentence in federal prison for a drug offense that he was convicted of in 1997, when he was 24 years old. Originally from the Norfolk area, Gadsden entered federal prison in 1997 with just an 8th grade education and an unflattering (mostly juvenile) criminal history. The combination of then-mandatory guidelines for cocaine offenses and errors at sentencing resulted in a life sentence with no hope of parole. After numerous appeals and pleadings by a team of DC attorneys, and more than 1,500 hours dedicated to his case over five years, Gadsden was resentenced to time served and released in November 2020. -Todd Mikolop and Ali Hamilton (Washington, DC) and Laura Colombell Marshall (Richmond)

Emanuel Lewis v. Dallas County Sheriff

Hunton Andrews Kurth represents a Dallas County Jail Detention Service Officer (DSO) and a class of other DSOs in a lawsuit against the Dallas County Sheriff, alleging that the Sheriff has failed to institute adequate protocols to mitigate the spread of COVID-19. The firm's client alleges that he and other DSOs were discouraged by supervisors from wearing masks and that inmates, including infected inmates, were forced to cluster in poor, unsanitary conditions, placing the DSOs at "extreme risk" of infection. The firm's client seeks an injunction compelling the Sheriff to institute mitigation measures consistent with the recommendations of the CDC.

Court-Appointed First Step Act Case

The firm accepted an appointment by the Fourth Circuit to represent Larry Reed in appealing a district court's denial of his motion under the First Step Act of 2018 to reduce the life sentence that he received in 1997 for his involvement in a drug distribution ring. Under that law, individuals like Mr. Reed may seek a reduction of sentence imposed before the passage of the Fair Sentencing Act of 2010, which addressed disparities in sentencing for certain drug crimes and lowered the maximum penalty for Mr. Reed's crimes to 40 years' imprisonment. Mr. Reed argues that his life sentence was improperly based on a 1997 "sentencing enhancement" for crimes he either was not charged with or was acquitted of, and that a sentence reduction is warranted, given his exemplary prison record. The Hunton Andrews Kurth team is cautiously optimistic that the Fourth Circuit will vacate the district court's denial of Mr. Reed's motion as an abuse of discretion and remand the case for re-sentencing. - Maya Eckstein, Trevor Cox and Michelle Hayden-Winston (Richmond), Nick Stellakis and Shauna Twohig (Boston) and Katy Boatman (Houston)

Southern Center for Human Rights

Since 2013, Hunton Andrews Kurth lawyers have been representing two brothers in habeas corpus proceedings. The clients have been imprisoned since 2006 for a murder committed by a third brother. In 2019, after years of state and federal habeas corpus proceedings, the US District Court for the Northern District of Georgia granted one of the brothers habeas corpus petition because their jury included a juror who was biased and the judge also ordered that he be released while the State's appeal was pending. In August 2020, Laura Wagner argued the appeal of his conviction in the very first Zoom oral argument before the Eleventh Circuit. Unfortunately, the Eleventh Circuit reversed the District Court's grant of the habeas petitions, ultimately holding that it was unclear, during voir dire, what a juror meant about his ability to be impartial. The HuntonAK team has now pivoted to assisting the brothers with their parole, as they now have been imprisoned far longer than prisoners with similar records.

UVA Appellate Litigation Clinic

Atlanta and Miami office lawyers are representing a Georgia state prisoner in an Eighth Amendment/Section 1983 case arising out of his deprivation of medical care. The client was infected with Hepatitis C while in prison and has not been provided regular testing to determine the appropriate course of treatment for his condition. His condition is deteriorating and the Eleventh Circuit recently found that he had adequately alleged a serious threat of physical injury because the Georgia Department of Corrections has failed to treat his Hep C and, in April 2021, it remanded the case to the US District Court for the Northern District of Georgia. – Larry Bracken and Andrew Koelz (Atlanta), Casey Coffey (Miami) and Reiko Koyama (Washington, DC)

Alliance for Children's Rights Adoptions

Through the Alliance of Children's Rights, Hunton Andrews Kurth's Los Angeles lawyers assist families adopting children through the Los Angeles County foster care system. Representation of Client in Extensive Family Law Proceedings

Hunton Andrews Kurth's Houston lawyers represent an indigent client in her ongoing divorce proceedings and fight for sole custody of her three young children. The husband, an alcoholic, took the family abroad and abused the client and her children. The client eventually fled the foreign country, with her children in tow, and returned to the US with little to no assets. Upon the husband's return to Texas, he continued the abuse during visitations with the children and repeatedly stalked the client and their children to the extent that law enforcement became involved. Through evidentiary hearings, the team successfully obtained protective orders against the husband, including third-party supervised visitations. JusticeServer

A coalition of Richmond law firms and corporate legal departments provided funding to create a virtual platform for case referrals for Richmond's legal service providers. The result of this decade-long effort is a case management system for Central Virginia Legal Aid Society (CVLAS) and the ability for lawyers to take cases from anywhere in Virginia for any client in Virginia. Through the JusticeServer platform, during the past year, Hunton Andrews Kurth lawyers handled more than 70 uncontested divorces for clients served by CVLAS, Blue Ridge Legal Services and Southwest Virginia Legal Aid Society. - Mike Nedzbala, Mark Wickersham, Sharon Harrington, John McNairy and Dennis Fairbanks (Richmond)

Virginia Holistic Justice Initiative Matter

A Hunton Andrews Kurth associate was approached by the Virginia Holistic Justice Initiative (VAHJI)—a non-profit organization working to leverage community resources to avoid incarceration for nonviolent offenders—to assist with a family law matter arising tangentially with one of its criminal matters. After VAHJI had successfully assisted a father and stepmother who faced false accusations that they assaulted the biological mother of the father's young son (resulting in the biological mother's own conviction for assault), the biological mother sought to modify the custody agreement granting sole custody to the father. Hunton Andrews Kurth has now assisted the family in preserving the sole custody order, securing a court order to create a payment plan for delinquent child support owed to the father, and petitioning for a name change for the minor. - Elizabeth Reese (Richmond)

HVL Guardianship Project

Houston pro bono fellow Henry Sturm presented a training on Alternatives to Guardianships to associates for the New Attorney Pro Bono Project, sponsored by Houston Volunteer Lawyers and the Houston Young Lawyer Foundation. As a result of the training, seven Houston lawyers took on guardianship cases that resulted in adults with minor intellectual disabilities having autonomy over their major life decisions while also formalizing their support network. Abuse in the Military

Hunton Andrews Kurth represented a military veteran in claims for service-connection disability benefits related to Military Sexual Trauma (MST). New York lawyers represented an Army veteran who was sexually assaulted by at least three members of her own unit. The trauma experienced during her service affected her mental health and she was diagnosed with depressive disorder and PSTD as a result. The team got the VA to grant service connection for PTSD and depression, providing the client with desperately needed disability benefits. The Hunton Andrews Kurth team is assisting the client in appealing an earlier decision in her case. Representation of Victims of Domestic Violence

Charlottesville pro bono senior fellow Geri Greenspan has represented Kari Collier in protective order and custody matters since she was assaulted by her partner in 2017. In 2020, Geri handled a day-and-a-half-long custody appeal in Albemarle Circuit Court, resulting in Kari winning sole legal and primary physical custody of her daughter. Geri also represented Kari in her motion to extend her protective order in the Juvenile and Domestic Relations Court, which was granted. Kari's abuser appealed that decision, and Geri represented Kari before the Circuit Court, again obtaining an extension of the protective order. Once her cases had concluded, Kari was able to pay it forward by speaking to UVA law students in Geri's gender-based violence seminar about her experience in the legal system.

After the State Department's Office of Children's Issues reached out to Hunton Andrews Kurth, the firm filed their petition in the US District Court for the Southern District of New York on July 31, 2020. They then moved the Court to enter an expedited schedule, which it did, scheduling a one-day trial for the week of September 21, 2020. The client's ex-husband quickly agreed to return the children to the client in the Dominican Republic. 

Protect Our Defenders Amicus Brief

Hunton Andrews Kurth filed an amicus brief in the Supreme Court in a case involving a cadet who was sexually assaulted at West Point. That case was dismissed on the basis of the judicially-created "Feres" doctrine. They filed the brief on behalf of Protect Our Defenders and a broad coalition of 19 other organizations that either have connections to the military or focus on sexual assault. While the Court decided not to review the case, Justice Thomas wrote a scathing dissent that reiterated arguments made in the amicus brief. - Maya Eckstein (Richmond) and Kelly Oeltjenbruns (Washington, DC)

Domestic Violence Survivors

In FY21, Hunton Andrews Kurth lawyers worked with women's shelters to assist domestic violence survivors with protective orders, divorces, custody cases and divorces. VETERANS

Hunton Andrews Kurth lawyers accept referrals for veterans matters from the National Veterans Legal Services Program, Houston Volunteer Lawyers, Veterans Education Success, the Dallas Volunteer Attorney Program and the United States Coast Guard, and lawyers provide tax assistance through VITA to veterans at Fort Lee in Virginia.

Lawyers provided pro bono legal services to the following non-profits that support veterans: the 1162 Foundation, the Bob Woodruff Foundation, Carolinas Freedom Foundation, Warrior Ethos and Check-6 Foundation.

Rudisill v. McDonough

Hunton Andrews Kurth argued Rudisill v. McDonough in the United States Court of Appeals for the Federal Circuit. The decision in the matter could restore billions of dollars in Post-9/11 GI Bill and other educational benefits to military service members of the Post-9/11 era. The VA appealed an earlier court victory in favor of the firm's client in March 2020. The case was featured in the Chicago Sun-Times. - Tim McHugh and David Parker (Richmond) lead the litigation team, with support from a number of other attorneys and staff across the firm.

Fourth Circuit Court of Appeals Matter for NVLSP

Hunton Andrews Kurth argued a NVLSP military records matter in the Fourth Circuit Court of Appeals. In April 2020, NVLSP, with the support of Hunton Andrews Kurth, appealed the decision of the US District Court for the Eastern District of Virginia dismissing NVLSP's lawsuit to compel the Pentagon to return all of the past decisions of the Discharge Review Boards and Boards for Correction of Military Records that the Pentagon had removed from its public reading room since April 2019. - Trey Sibley with assistance from Elizabeth Reese, Stephanie Meharg, Sarah Ingles and Pierce Lamberson (Richmond).

Disability Compensation Regulations Comments for NVLSP

Hunton Andrews Kurth drafted comments for NVLSP on the Department of Veterans Affairs' proposed changes to disability compensation regulations that would limit the availability of benefits for conditions aggravated over time. Among other things, the proposed changes seek to avoid favorable court decisions secured by NVLSP and are strongly opposed by national veterans groups. COVID-19's Impact on the Department of Defense and Veterans Affairs

Hunton Andrews Kurth is assisting in researching, monitoring and, if necessary, submitting inquiries to various Department of Defense (DoD) and VA offices to determine whether they are still accepting applications and claims for benefits, have postponed or cancelled scheduled hearings and/or are allowing for extensions of filing deadlines or other similar relief due to COVID-19. Veterans want to know how this pandemic is affecting the day-to-day processes of the DoD and VA, including Boards for Correction of Military/Naval Records, Discharge Review Boards, Board of Veterans' Appeals, VA Regional Offices and the Court of Appeals for Veterans Claims. Representation of Victim of Sexual Assault in the Military

Hunton Andrews Kurth recently achieved a victory for a veteran who served as a private in the US Army, where he was subjected to unwelcome sexual contact and advances by a male superior officer. In 2015, the client submitted a claim for additional benefits due to PTSD, which he developed as a result of Military Sexual Trauma (MST). The VA denied his claim, denied the claim again on higher-level review and then denied a supplemental claim submitted with new medical evidence. The VA's 2019 ruling found that there was insufficient medical evidence that the client suffers from PTSD. Hunton Andrews Kurth took over his case at that point after it was referred by NVLSP. The team submitted a new request for higher-level review, where they briefed the factual and procedural background to his claims, reorganized the medical evidence, and highlighted errors in the VA's denial decision. This convinced the VA to order a new exam of the client, and it then concluded that he had proven his claim for PTSD due to MST. He received a 70 percent disability rating, and has already received \$23,880 in back benefits. - Christy Kiely (Richmond)

Combat-Related PTSD for Decorated Marine

Hunton Andrews Kurth assisted a Marine who served from February 2009 to July 2017 as a bulk fuel specialist. He deployed to Afghanistan in 2010 and again in 2012. During the 2012 deployment, he was a witness to gruesome injuries, i.e., mangled bodies injured in IED blasts. He was provided a medical retirement for Post-Traumatic Stress Disorder (PTSD), rated at 50%, with the explicit finding that his PTSD was the direct result of a combat-related injury. Ben Ackerly filed an initial application for Combat-Related Special Compensation (CRSC), along with a Memorandum in Support for CRSC on March 4, 2020. On April 13, 2020, the Department of the Navy awarded CRSC to the veteran. He also received his retroactive pay in the amount of \$17,340.00. - Ben Ackerly (Richmond)

Personality Disorder Discharge Upgrade

Hunton Andrews Kurth is assisting a US Navy veteran who was separated from service due to an alleged personality disorder after having problems adjusting to deployment while in Iraq. He was involuntarily separated from service a month after being diagnosed with Narcissistic Personality Disorder. A year after his discharge he was evaluated by a VA psychiatrist who diagnosed him with an adjustment disorder and determined that the personality disorder diagnosis was made in haste. The veteran has not been diagnosed with a personality disorder since his departure from the Navy, and instead is currently diagnosed with Major Depressive Disorder. The firm is assisting the veteran in submitting an application for a discharge upgrade, in an effort to secure for him the full range of benefits to which he is entitled. - Kristy Bulleit (Washington, DC)

Merrill's Marauders Receive Congressional Gold Medal

Veterans of a top-secret US Army unit, Merrill's Marauders, who fought behind enemy lines in the jungles of Burma in World War II, received the Congressional Gold Medal with the help of Hunton Andrews Kurth lawyers and staff. A HuntonAK team assisted two of the eight surviving Merrill's Marauders in enlisting congressional support for the recognition. - Fred Eames (Washington, DC)

Combat-Related Special Compensation for a Combat Medic

Hunton Andrews Kurth helped a US Army Combat Medic file an application for Combat-Related Special Compensation ("CRSC"). The veteran served his country from September 2009 to May 2017 and deployed to Afghanistan from December 2011 to November 2012. He received more than ten awards during his service, including a Combat Medical Badge, an Afghanistan Campaign Medal with Campaign Star, two Army Commendation Medals and a NATO Medal. He was struck by an Improvised Explosive Device (IED) blast while deployed. As a result, he sought treatment for smoke inhalation, headaches, confusion, ringing of the ears and anxiety. He also sustained an ankle injury and was exposed to hostile fire while deployed. The application for CRSC was submitted on July 2, 2020 and the veteran received an award letter from the US Army dated August 12, 2020 approving his claim for CRSC, rated at 60% disabling. – Paul Ackerman (New York)

Norfolk Coast Guard Representation

Hunton Andrews Kurth represented a Coast Guard member and his wife who were sold a vehicle with a promise of certain specifications that did not exist in the vehicle. The firm successfully obtained a settlement for the couple from the car dealership. - Bob Tata (Norfolk)

He acknowledged he has made no effort to pay alimony during the last two years. The Judge was asked to hold the ex-husband in willful contempt. Matt submitted a proposed order with the petition.
